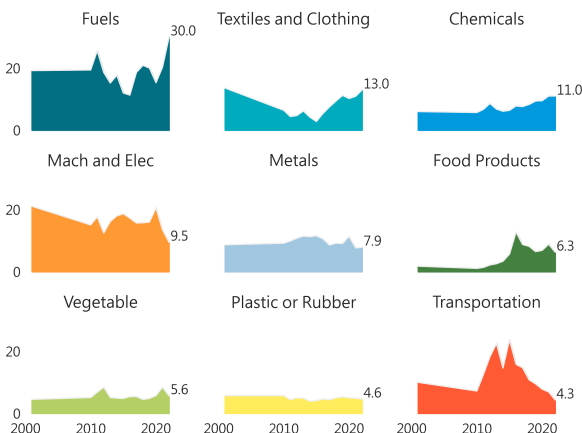
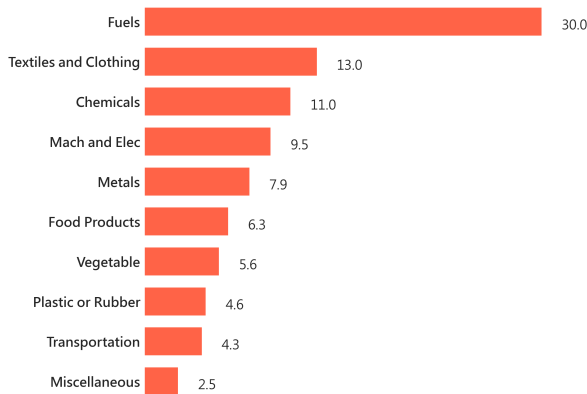
Top Exports, by % of total value (2020)

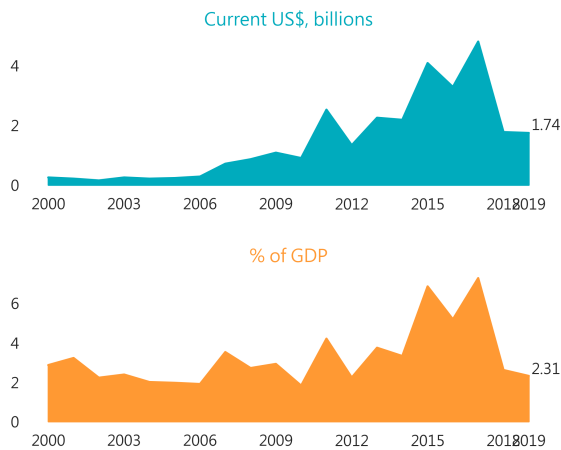
Top Imports, by % of total value (2020)

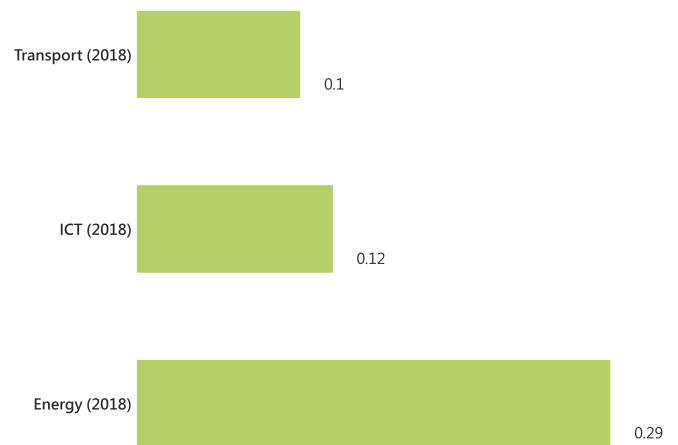

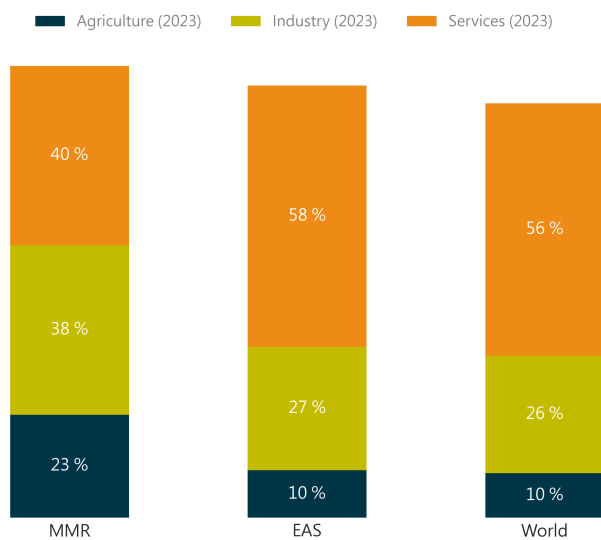
Inv. with private participation (USD, bn.)



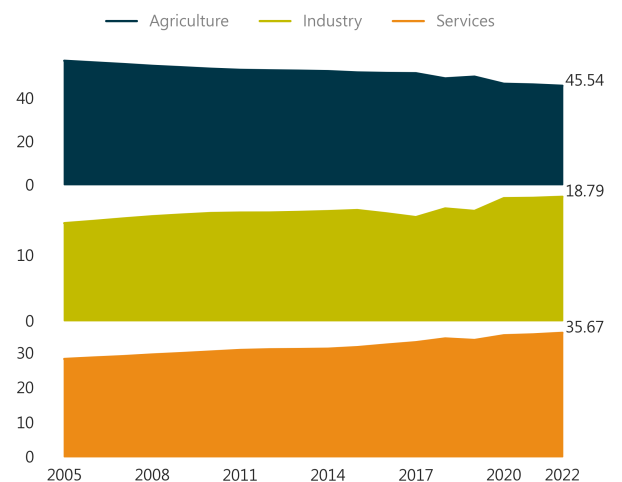
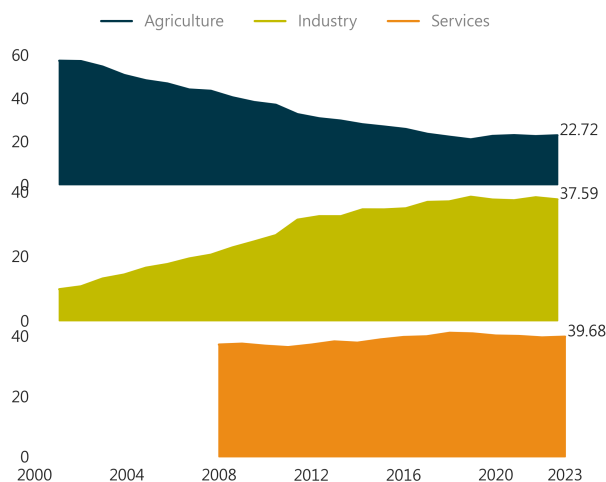
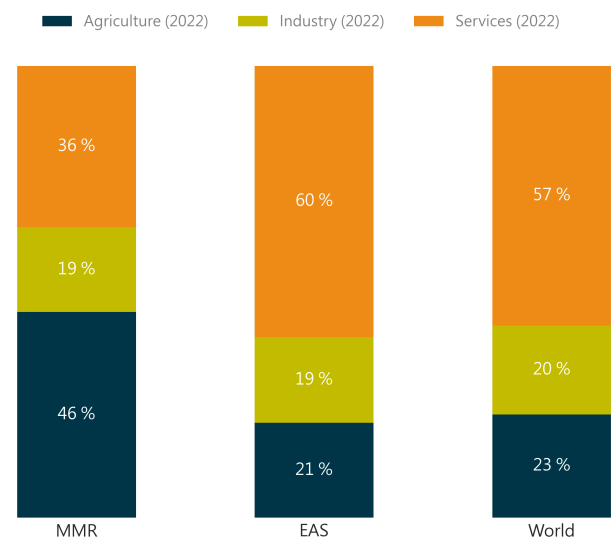

Value added, % GDP

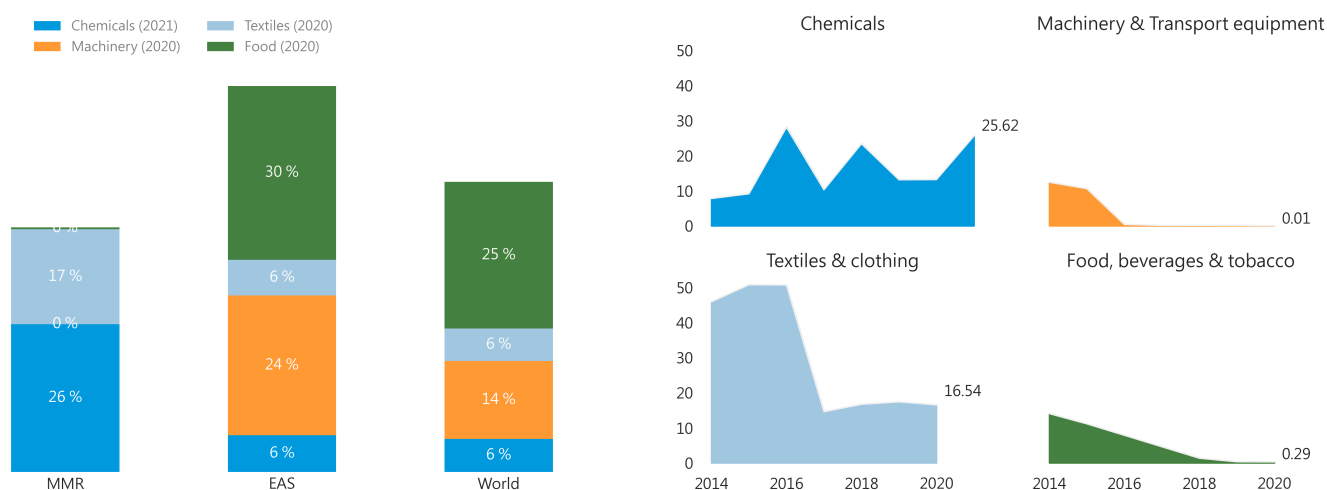


Employment, % of total

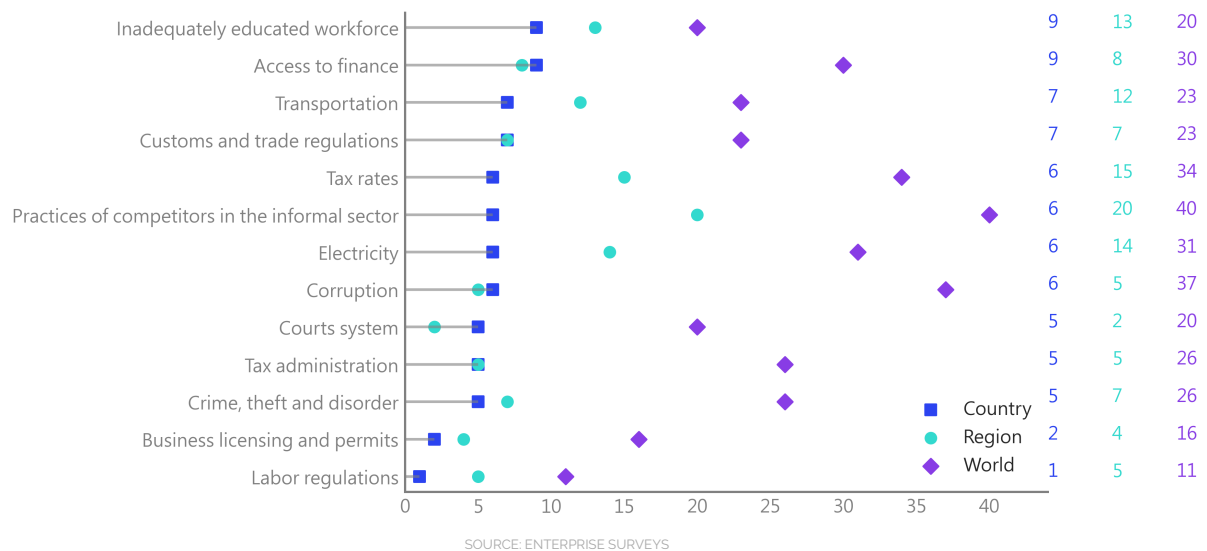

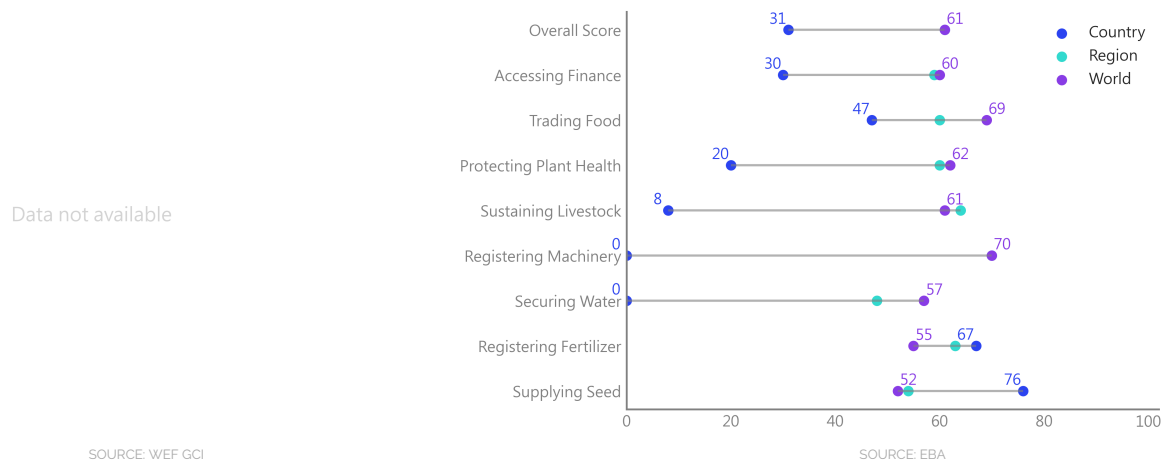

Enterprise Survey - Constraints (2016)

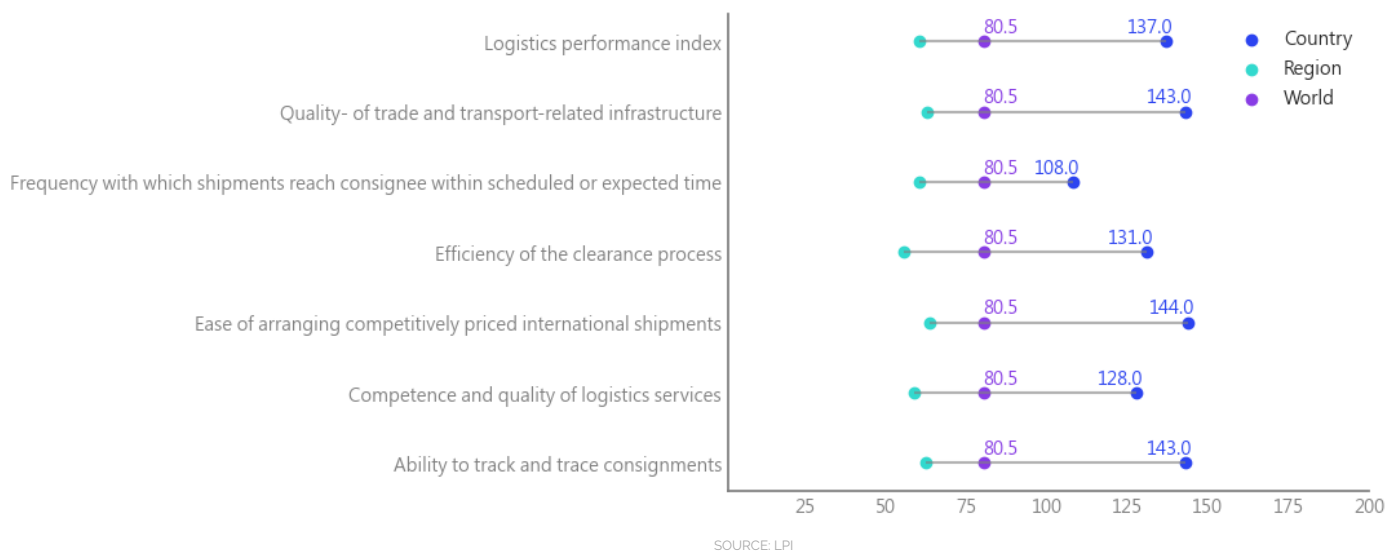


Global Competitiveness Index
